Terms of Participation:

I understand that my participation (or the child in my care's participation) is at my own risk and I understand that this risk is at my own expense. I hereby waive Every Season My Season from all and any claims, actions, losses or other suits for bodily injury, property damage, wrongful death, loss or otherwise which may arise out of participation in this academy. In giving this release, you warrant that you understand you are releasing and waiving any claims actions that you may have presently in the future.

- o I parent/guardian/player agree to be bound by these terms and conditions, which are subject to change at our discretion.

- o I parent/guardian/player agree that the registered player/participant will adhere to all ESMS terms and conditions in accordance with all aspects outlined in our Code of conduct. This forms part of the conditions of enrolment.

- o ESMS reserves the right to alternate coaching arrangements for all programs based on availability

- o ESMS may notify of change our venues, times and or coaching arrangements subject to our discretion.
 - o If you are unable to attend a particular training session, or any part of the academy, you must notify the ESMS Director as soon as practical
 - o In addition to any requirements in our terms and conditions, you must comply with all relevant requirements of the venue at which the academy training sessions occur.
 - o By agreeing to being bound by these terms and conditions, you represent and warrant that you are 18, or if you are entering into these terms & Conditions on behalf of any person under 18, that you are the persons parent or legal guardian. You must inform any persons under 18, about these terms and conditions and their obligation to comply with them.
 - o In the event you may cancel or fail to attend a training session or any part of our academy including holiday clinics, replacement sessions are not applicable, or refundable
 - o I understand that for each training session I am required to book in my training session at least 12 hours prior the schedules commencement time

Payment Details/Subscriptions

o If at any time scheduled training sessions are cancelled due to weather conditions or the sessions is dated on a public holiday, fees paid via direct debit will be applied

o Charges for the Academy are based on subscription fees as published on our website

School Holiday Period

o All Academy members will be eligible to attend the first 2 hours of ESMS holiday clinic as part of their membership. (First day of clinic only). During this period, training will not be on Monday at 5:45pm. Training will take place on Wednesday, April 12th 9am to 11am.

o Should you wish to attend the full holiday clinic, you will not be charged the \$30 subscription for that week. You will only pay the holiday clinic purchase price before resuming your membership the following week.

- Should any one of our holiday clinics be cancelled for any reason (including weather conditions, availability of fields etc.), ESMS will apply credit to a future clinic

Parent/Guardian Agreement

- ESMS allow the parent/guardian to observe training sessions although, we do request the following guidelines be followed
 - Please remain outside the set boundaries of each training session
 - Parents are not authorised to approach students or coaching staff during training sessions. Coaches are accessible after the session time.
 - Parent's must refrain from coaching from the sidelines or attempting to distract theirs or any other student during a training session
 - Parents who choose to leave during the training sessions must ensure they are back to the training area on time to collect their child as we are unable to take responsibility for the student after the session concludes
